We hoped to complete a Capital Project, decks on Golf Course Road, in the spring of 2020. The project was delayed due to difficulties caused by COVID-19 in obtaining engineering plans and scheduling contractors. We will carry over the work into this new fiscal year.

So far all staff and their families are healthy, and we are taking precautions such as limiting social interactions, offsetting lunch breaks, wearing masks in the office and when indoors when on site to the fullest extent possible. It has been a little more stressful than normal for them handling trash and cleaning up behind owners in the hallways, elevators, and pools. We hope owners are taking proper precautions.

We have ordered new ladders for the Wheeler pool. Our disinfecting wipe stations for both pools took 6 weeks to arrive but seem to be working fine. The staff is doing daily disinfecting of touch surfaces, including on weekend. Many condominium associations have not opened any common facilities.

The weather has been hot and wet which contributed significantly to plant growth and weed growth in particular. Due to the wet weather the tree contractor is a little behind on removals. It saves us quite a bit of cost to

have them go in with their boom truck for removals, especially in tight areas close to or above buildings.

The rainfalls have caused a few leaks, mainly on buildings nearing roof replacement and a few foundation issues. We are working on making and coordinating repairs.

Our roofers are finalizing costs for roofs to be done this year and we will be starting later this summer. We will also be getting costs for the 2021 roof replacements. We are looking into different products for shingles and underlayment to extend the life of the new roofs and make them more hail resistant.

We are painting and weatherproofing some of the stucco buildings on Golf Course Road. We washed them and are sealing cracks in the stucco in preparation for the painters.

President's Report: Goodnow moved to reinvest a CD, maturing on August 5th at Summit, in a CD at Bank of Sun Prairie for 12 months at 0.75%, which unfortunately is the best rate available. Seconded and passed.

The Board went into Executive Session at 6:47 and returned to regular session at 6:50.

New Business:

Water heater warranty replacement: Unit owners in two buildings have been special-assessed for the costs of installing new water heaters. The new heaters have had to be replaced due to issues covered by warranty. While the replacement heaters were covered by the warranty, the installation costs

were not. Moved, seconded, and passed that the Association, not the unit owners, should pay for the plumbing repairs to install the replacement heaters.

An estate, which owns 1410-F, wants to sell the unit's third parking space to the Association for the assessed value of \$2,000. The Association has the right of first refusal. Moved, seconded, and passed (approve: 7; abstain: 1) to purchase the space for \$2,000. Tom notes that it can be used for equipment storage, rented out, or resold.
